Guarantee will be returned when the Carnet is surrendered to SACCI, and found to be correctly discharged. No guarantee refund will be considered without original Carnet.

I understand that ATA Carnet deposit/guarantee refund **may** be made within 30 working days after receipt of **original** Carnet and once SACCI establishes that the carnet has been completed to the satisfaction of both foreign and SA Customs (SARS) authorities. No interest on deposit payable by SACCI. I further agree that SACCI will not refund the Issuing fee for Carnet not used and/or cancelled.

I agree to pay SACCI immediately upon receipt of its demand in writing, all or any such sum, or sums of money which may have been paid, or be called upon to pay in respect of any duties, taxes and any charges which may be incurred by SACCI as a result of, or in connection with, the issue of the Carnet.

I further agree that as the Carnet Holder, we continue to be bound by the conditions signed herein to pay SACCI all charges resulting from any future action which may be initiated by any relevant Customs authority within the 31-month period.

I have read and understood the conditions of the guarantee, and declare that the above particulars are true and correct and I undertake to return the Carnet to SACCI after use. The use of the Carnet does not absolve the holder from observing the Customs regulations of the countries operating the scheme. For example, in certain circumstances a South African export license, or an import/export license for countries to be visited, or crossed in transit, may be required.
